By signing below, I understand and agree to the following:

1. Owner(s) is responsible to pay for and install sewer pipe from the main sewer line to any dwelling.
2. Owner(s) is responsible to pay for and install water pipe from the curb stop to any dwelling.
3. Owner(s) is responsible to pay for and install the Town approved water connection equipment/register and associated parts to any dwelling.
4. The property owner(s) are responsible to have all licensed contractors, and licensed subcontractors, request a main locate prior to any digging. Requests can be made by calling the Town Office who will notify the Alpine Maintenance Supervisor and/or his designee.
5. The owner(s), contractor(s), or subcontractor(s) will be responsible for any damage to the Town of Alpine's property and/or damage incurred by the owner(s), contractor(s), or subcontractor(s).
6. Failure to schedule and complete a main locate will result in added liability of the owner(s), contractor(s), or subcontractor(s) and may result in a fine.
7. The Town recommends owner(s) to use 4-inch PVC SDR-35 sewer pipe. Any connection larger than 4 inches requires a construction permit from the Department of Environmental Equality.
8. It is highly recommended that a shut off valve be installed on the owner's side at the curb stop.
9. The Town requires you to have a final inspection by the Town Water Operator and/or his designee before any back fill is done to your sewer hook-up.
10. A Sewer connection must be utilized within two (2) years from the date on which fees are paid. I understand my application will expire and a new one will need to be filled out and the applicable fees paid.
11. A connection to the Town water system must be completed within one (1) year from the date of payment. I understand my application will expire and a new one will need to be filled out and the applicable fees paid.
