

**278 ORDINANCE NO. 2021-01**

**TOWN OF ALPINE BUDGET FOR FISCAL YEAR 2020/2021**

AN ORDINANCE AMENDING THE TOWN OF ALPINE BUDGET FOR FISCAL YEAR 2020/2021 AS ADOPTED BY THE TOWN OF ALPINE ON JUNE 16, 2020.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF ALPINE, LINCOLN COUNTY, WYOMING THAT 275 ORDINANCE NO. 2020-04 TOWN OF ALPINE BUDGET WILL BE REPEALED AND REPLACED BY 278 ORDINANCE NO. 2021-01.

SECTION 1: THAT THE FOLLOWING MONIES SHALL BE SET ASIDE AS ANTICIPATED FOR THE REVENUES, EXPENSES, AND OTHER DISBURSEMENTS OF THE TOWN GOVERNMENT, COMMENCING ON JULY 1, 2020 AND ENDING JUNE 30, 2021.


