# Fight the Bite—Help reduce the Mosquito Population



Its that time of year again and we need your donations to help control a dangerous health threat in our recreational area.

Currently, no vaccine against WNV infection is available. The best method to reduce the rates of WNV infection is mosquito control on the part of municipalities, businesses and individual citizens. West Nile virus (WNV) is most commonly transmitted to humans by mosquitoes. WNV has been detected in every county in Wyoming, so it is important to reduce your risk of being infected with WNV by using insect repellent and wearing protective clothing to prevent mosquito bites. There are no medications to treat or vaccines to prevent WNV infection. Fortunately, most people infected with WNV will have no symptoms. About 1 in 5 people who are infected will develop a fever with other symptoms. Less than 1% of infected people develop a serious, sometimes fatal, neurologic illness.

We are beginning the season where **Alpine Recreation Development Association (ARDA)** has the mosquitos by the lake and surrounding areas baited and trapped for disposal. We need your help! If you enjoy the lake and don't want to be bitten, get infected or sick, then please donate to this worthwhile cause. All donations are greatly appreciated and ALL DONATIONS spent on this project are in order to keep our area free from these pesky and dangerous insects.

Vector Mosquitos can cause people to become sick and they carry the West Nile Virus. Everyone needs to be vigilant by staying indoors and covered as much as they can during the dawn & dusk hours between 5—7:30 p.m. Although mosquitoes are most active at dusk or dawn, some bite during the day. Mosquitoes will bite if you enter an area where they are resting, such as high grass or heavy underbrush. While it is not necessary to limit outdoor activity (unless there is evidence of mosquito-borne disease in the area), you can and should reduce your risk of being bitten by mosquitoes.

Common sense steps you can take to minimize the probability of infection include remembering the

## 5 D's of West Nile Virus prevention:

- 1. **DAWN** &
- 2. **DUSK** When possible, avoid spending time outside at dawn and dusk.
- 3. **DRESS** Wear shoes, socks, long pants, and a long-sleeved shirt when outdoors for long periods of time or when mosquitoes are most active. Clothing should be light colored and made of tightly woven materials to keep mosquitoes away from the skin.

- 4. **DRAIN** Reduce the amount of standing water in or near your property by draining and/or removing it. Mosquitoes may lay eggs in areas with standing water.
- 5. **DEET** For additional protection from mosquitoes, use an insect repellent containing DEET (N,N-diethyl-m-toluamide) or picaridin (KBR 3023). Other insect repellents such as oil of lemon eucalyptus and IR3535 are also registered by the EPA but may be less effective than products containing DEET. It is important to follow the product guidelines when using insect repellent.

If you enjoy summer activities on or near the area water ways, please help make it safer. Vector Mosquitoes carry West Nile Virus and can transmit other dangerous infections.

All donations to ARDA go to mosquito control efforts. Mosquitos are most active at dusk. Egg laying females primarily feast on blood. This isn't your average ordinary wood Mosquito—this is your evil nasty vengeful water mosquito!

## Alpine Town Council has set a work session schedule for 2023

### Work Sessions - Use by Legislative Bodies

Introduction

Work sessions must be posted and fall under the definition of a meeting in the Open Meetings Act. Also, they must be open to the public except for those issues that by law are permitted to be addressed in closed session. Several common issues or questions are addressed below and addressed not as "legal" issues but rather as policy or decision-making issues.

When should work sessions be scheduled?

Work sessions can be scheduled at any time. If scheduled immediately prior to regular sessions, items on the agenda are also placed on the work session agenda. If there are any questions on issues, they can be addressed in the work session. If scheduled on the off week, work sessions mean more meetings, more staff preparation and potentially greater public perception problems if work sessions are not well-attended or televised. If the public isn't aware of work sessions, it may appear that decisions have already been made by the time council acts in a regular meeting.

## What purposes do they serve?

Work sessions can be vehicles for addressing major issues more effectively. They can also provide opportunities for members to focus on long-term decisions rather than the day-to-day management issues that confront the town. Presumably they also make regular sessions more productive and shorter. Work sessions can also help members relate better to one another because of the areater informality of such sessions.

What kinds of items should be on the agenda of work sessions?

An alternative approach to duplicating regular meeting agendas is to reserve work sessions for "blue sky" issues or major projects only. Goal-setting, budget review or major development proposals are examples. If every issue is on both the work and regular session agenda, it may become repetitive.

### Must the public be allowed to participate?

Work sessions are intended to provide opportunities for council/board members to study difficult issues, gather and analyze information, and clarify problems. The public must be given an opportunity to address the council/board. If council is going to have a meeting, and it is a posted public meeting, then people must have an opportunity to speak under the Open Meetings Act. That is perfectly fine, but rules governing public participation ought to be enforced, and those in attendance should be made aware of the purpose of the meeting—to study issues, not to take action.

## IT'S TIME TO RENEW YOUR CAT OR DOG LICENSE

For the month of May animal licenses will be 1/2 off.

All dogs or cats shall be licensed within thirty (30) days of taking residence in the Town of Alpine. Each dog or cat license expires on May 31st of each year and pets need to be licensed annually. License fees are \$10 for an altered dog or cat and \$50 for an unaltered dog or cat. . A copy of a current rabies vaccination from a certified veterinarian is required for licenses.
