## 5. ACTION ITEMS/NEW BUSINESS:

 Motion for Approval of the Final Minor Subdivision Application (Replat) for "Broulim's Addition" to the Town of Alpine; Development Agreement and to Authorize Mayor Lutz to Sign the Development Agreement and Mylar on Behalf of the Town of Alpine.

Councilman Larsen moved to approve the Final Minor Subdivision Application (Replat) for "Broulim's Addition" to the Town of Alpine; Development Agreement and to authorize Mayor Lutz to sign the Development Agreement and Mylar on behalf of the Town of Alpine. Councilman Fritz seconded the motion. Discussion ensued. Councilman Larsen expressed his and the town citizens' desire that Broulim's new store remain open on Sunday. The consensus was that while the council agreed, the town cannot compel Broulim's to open on Sundays as a requirement of the replat approval. Vote: 5 Yes, 0 No, 0 Abstain, 0 Absent. Motion Carried.

• Planning and Zoning Commission Update – Tim Hartnett

Mr. Tim Hartnett of the Planning and Zoning Commission reported that at the last Planning and Zoning meeting the commission recommended approval of a minor subdivision plat at the Broulim's property following a brief phone discussion with Marlowe Scherbel to clarify some parking questions. The commission approved two single family residential building permits. Both applicants were available and participated in the process via phone. That took care of the business for this meeting.

Mayor Lutz thanked Mr. Hartnett for his report.

• Approval on Third Reading of 272 Ordinance No. 2020-01"Regulating Recreational Fires within the Incorporated Limits of the Town of Alpine"

**Councilman Larsen moved to adopt on third reading 272 Ordinance No. 2020-01 "Regulating Recreational Fires within the Incorporated Limits of the Town of Alpine". Councilman Fritz seconded the motion.** Discussion ensued. Councilman Larsen stated that the ordinance should contain a provision added to Sections 4 and 5 to accommodate public complaints so fires may be put out. For instance, if smoke from a neighbor's fire is coming through your window you should be able to call the Alpine Fire District and have the firemen put out the neighbor's fire. Another suggestion was to simply go next door and ask that the fire be extinguished or to close your windows. No consensus was reached. Tabling the decision for adoption would allow time for the council to prepare alternate language to cover their concerns.

## Councilman LaPier moved to table the approval on third reading of 272 Ordinance No. 2020-01. Councilman Fritz seconded the motion. There was no discussion. Vote: 5 Yes, 0 No, 0 Abstain, 0 Absent. Motion Carried.

Councilman Larsen moved to adopt on second reading 273 Ordinance No. 2020-02 "Regulating Noxious Weeds within the Incorporated Limits of the Town of Alpine". Councilman Fritz seconded the motion. Discussion ensued.

Ms. Meta Dittmer of the Alpine Noxious Weed Advisory Committee (ANWAC) submitted the following comments:

- Section 2, puts the responsibility for spraying the rights-of-way on the landowners not the town as is customary;
- Section 3 requires AWAC to send certified letters demanding eradication of noxious weeds and this should be done by Lincoln County Weed and Pest (LCWP) or the town office; and
- Section 4 allows the LCWP or town maintenance personnel to exterminate noxious weeds on personal property but not the ANWAC. Could ANWAC be added to the list of persons authorized to exterminate weeds?

Discussion ensued with the council and Mr. Sanderson discussing the right to and ramifications of accessing personal property. The council did not reach a consensus on accessing personal property; however, the other two suggestions could be added to the draft ordinance. The ordinance needs to follow county and state regulations. This will be discussed further on third reading.
