A RESOLUTION TO ADOPT THE VACATION OF A PORTION OF ELK DRIVE AND THE COMBINATION OF LOTS 7 AND 8 OF THE ALPINE WEST FIRST ADDITION, LOCATED WITHIN THE TOWN OF ALPINE IN THE NW ¼ SW ¼ OF SECTION 29 AND THE SE ¼ OF SECTION 30, T37N ,R118W, TOWN OF ALPINE, LINCOLN COUNTY, WYOMING.
