ALPINE TOWN COUNCIL MEETING MINUTES JANUARY 4, 2023

Mayor pro tem Fritz called the meeting to order at 7:00 p.m.

Councilman Dickerson seconded the motion. There was no discussion. **Vote: 4 Yes, 0 No, 0 Abstain, 1 Absent (Lutz).**

Town Clerk, Monica Chenault, administered the oath of office to Mayor Elect Eric Green. Mayor Eric Green administered the oath of office to Councilman Elect Jeremiah Larsen and Emily Castillo.

Mayor pro tem Fritz congratulated the newly elected officials and wished them well during their terms.

Mayor Green and Councilman Castillo took their seats at the council table. Mayor Green thanked those in attendance and noted that his administration's main goal is to do what is best for the Town of Alpine.


